

Schools of Thought: DC's New Generation of School Buildings

Over the last decade, the District of Columbia has made a substantial investment in modernizing its public school buildings, and the city's public charter schools and private schools have also made major investments in their facilities.

The design of these new and renovated schools has moved the architecture of learning spaces well beyond the basics of traditional school design. Like DC's widely praised new public library buildings, these modernized school buildings employ innovative architecture to better achieve their mission.

What prompted the District's school rebuilding effort? What difference does good school design make for student learning? And what design features do the city's new school buildings incorporate? This exhibition explores these questions by looking at 19 of the District's modernized public, public charter, and private schools.

In the 1990s, the physical conditions at DC public schools had reached a low point. Capital funding ranged from low and undependable to nonexistent. The city had stopped enforcing the fire code in its schools, schools were frequently closed due to unsafe conditions, enrollment was dropping precipitately, and these alarming conditions were frequently headline news.

How did the District of Columbia transform from dangerous conditions to its current bright, inviting, and architecturally award-winning inventory of modernized schools worthy of the nation’s capital?

It started with a lawsuit and ended with a fully-funded modernization program. During the period from 1990 to 2007, a group of loosely-organized but highly-committed individuals and groups came together to fight for the District’s schools and build the foundation for what became the DCPS Modernization Program. The story behind this program’s launch has since gotten lost – but it is a necessary one to tell.

It is a story that is not only important for the District to understand, but also a larger and more profound lesson for other urban school systems on how to make change.

In this two-hour session, students will serve as both client and designer for a *School of the Future*. Starting with a small group session, students will brainstorm about values, learning styles, and space types that may be present in future schools, before the larger group reviews some architectural images to help get their designer juices flowing. The class will set out to identify a common set of values and components to guide the design exercise before breaking up to create a model of their own *School of the Future* for the remainder of the session. Class will be led by primary and secondary school (K-12) architects and designers from Perkins Eastman and Perkins Eastman DC.
