Marshall was a member of the DC Chapter of AIA for 55 Years. During his tenure he made numerous contributions including serving on the Board of Directors, Chairing the Fellows Committee and serving on the AIA National Federal Architecture Task Group. His other honors included Council, National Organization of Minority Architects; recipient of National Institute of Building Sciences' inaugural Mortimer M. Marshall Jr. Lifetime Achievement Award; Tuskegee North-Eastern "Alumni Achievers Award" and Construction Alumni Association's Pioneer Award and the 2012 Whitney M. Young Jr. Award

A memorial service took place on Friday, June 15, 2018 in conjunction with that of the late Betty LaVerne Marshall, his wife of 66 years, who passed away on April 26, 2018. Mortimer M. ## Risk Management Tips: The Dreaded Duty to Defend

Owners frequently ask architects to sign indemnification provisions which include a duty to defend the Owner in certain circumstances. Although indemnification provisions are commonplace in the industry, a duty to defend provision – often buried in an indemnification provision – presents an uninsurable risk to the architect; that is, the architect's professional liability insurance will not pay for the cost of defending the owner against claims of alleged error or omissions in the design documents. This article briefly addresses the risk to the architect in assuming a duty to defend the owner.

A design professional's obligation under an indemnification clause should be limited to compensating its client for damages incurred by the client, but only if those damages were caused by the design professional's negligence. The indemnification obligation should not be triggered until there has been a legally binding determination that the design professional was negligent.

Project owners (and contractors in the design-build setting) frequently request much broader indemnification clauses which would require the design professional to defend their client from claims, demands, or lawsuits that are brought against the client. By obligating the design professional to defend its client, a design professional is contractually obligated to take legal action in defense of its client, even where the design professional was not at fault.

In general, professional liability policies exclude coverage for contractual liability related to a duty to defend. The consequence of signing a contract containing a "duty to defend" clause is revealed in URS Corporation v. Fort Myer Construction Corporation, a case recently appealed to the Court of Appeals of Maryland. This case was initially brought by the contractor against the owner seeking to recover additional costs allegedly due to errors in the design documents. The owner filed a third-party complaint against the design professional, seeking to have the design professional defend and indemnify the owner from the contractor's claims. On the eve of trial, the contractor dismissed its claims against the owner without prejudice (so that the contractor could refile the lawsuit in the future); however, the owner's claim against the design professional based on the duty to defend clause proceeded to trial. The trial court enforced the duty to defend clause, and ordered the design professional to pay the owner's attorneys' fees in the amount of \$352,355.68 (in addition to the \$248,638.31 it paid to its own attorneys!). While not discussed in the case, it is unlikely that the professional liability carrier provided coverage for the design professional's liability to the owner under the duty to defend provision, meaning that this was probably an out-of-pocket loss for the design professional.

Fortunately, such risk exposure may be prevented through effective risk management. Best practices require a thorough review of the contract prior to execution with special attention to the indemnification clauses. The design professional should strike out the word "defend" from the clause, and remove other language that would require the design professional to assume legal responsibility not contingent on the design professional's negligence. By exercising sound risk management practices in negotiating the indemnity provisions, a design professional can significantly reduce its exposure to uninsurable risks.
